ACCOUNTANTS' REPORT FOR INCLUSION IN THE PROSPECTUS OF SENKADAGALA FINANCE PLC

This report has been prepared for the purpose of the Prospectus issued in connection with the issuance of 20,000,000 Senior, Unsecured, Listed Redeemable, Rated Debentures of LKR 100/- each, aggregating to a value of LKR 2,000,000,000 (Rupees Two Billion) with an option to issue up to a further 10,000,000 Debentures to the value of LKR 1,000,000,000 (Rupees One Billion), in the event the initial 20,000,000 Debentures are oversubscribed.

We have examined the financial statements of Senkadagala Finance PLC from the financial years ended 31st March 2012 to 31st March 2016, and report as follows;

1. INCORPORATION

Senkadagala Finance PLC ("the Company") is a public quoted company incorporated in Sri Lanka on 29th December 1968 under the Companies Act No. 17 of 1982, and re-registered as per Section 5 of Companies Act No. 7 of 2007, under the registration No. PB238PQ. The shares of the Company have a secondary listing on the Colombo Stock Exchange.

It is licensed by Central Bank of Sri Lanka to conduct finance and related activities such as accepting customer deposits, savings, finance leasing, hire purchase finance, etc, under the provisions of Finance Business Act No. 42 of 2011.

2. FINANCIAL STATEMENTS OF THE COMPANY

2.1 Five Years Summary of Financial Statements

A summary of the income statement and statement of financial position of the Company for the financial years ended 31st March 2012 to 31st March 2016, based on the audited financial statements are set out on Annexure 01 to 04 of the Accountants' Report.



2.2 Audit Reports

We have audited the financial statements of the Company for the financial years ended 31st March 2012 to 31st March 2016. Unqualified audit opinions have been issued for the said financial years.

2.3 Application of Accounting Standards and Accounting Policies

The financial statements of the Company for the financial years ended 31st March 2012 to 31st March 2016 comply with Sri Lanka Accounting Standards.

The accounting policies of the Company are stated in detail in the Audited Financial Statements of Senkadagala Finance PLC for the year ended 31st March 2016.
